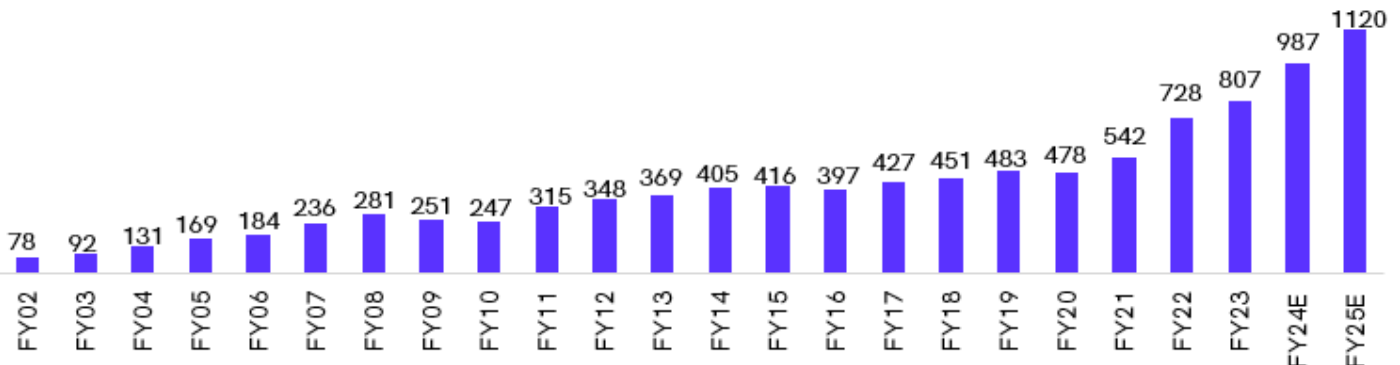

Equity Market

Indian Equity Markets: August 2024

Equity markets turned volatile in the first week of August, as the BoJ's interest rate hike led to the unwinding of carry trades, and weak US labour data sparked fears of a recession. However, the markets rebounded the following week on dovish guidance from the BoJ and better-than-expected weekly jobless claims data. The Indian equity markets closed the month at record highs.

The Nifty 50 and BSE Sensex indices recorded monthly gains of 1.1% and 0.8%, respectively, in August 2024. Foreign Portfolio Investors (FPIs) were net buyers for the third consecutive month. FPIs bought US\$0.8 bn, while Domestic Institutional Investors (DIIs) bought US\$5.8 bn during the month.

The broader market indices also closed higher, with the BSE Midcap and BSE Smallcap indices recording monthly gains of 0.9% and 1.2%, respectively. Among the sector indices, healthcare, Teck and consumer durables registered monthly gains of 6.6%, 4.6% and 4.4%, respectively. On the other hand, Utilities and PSU underperformed with monthly losses of -3.8% and -3.7%, respectively.

India's Q1FY25 Gross Domestic Product (GDP) growth was recorded at 6.7% YoY, down from 7.8% YoY in the previous quarter and below the RBI's forecast of 7.1% YoY. However, Gross Value Added (GVA) recovered to 6.8% YoY from 6.3% in the previous quarter, as strong services sector activity offset the slowdown in manufacturing. Agricultural growth was muted due to poor rabi crop production. On the expenditure side, private consumption recovered to 7.4% YoY in Q1 from 4.0% in the previous quarter, while fixed investment growth remained robust at 7.5% YoY.

The RBI's Monetary Policy Committee (MPC) voted 4-2 to keep the repo rate steady at 6.5% and retain the stance of withdrawal of accommodation. The RBI retained the FY25 real GDP growth estimate at 7.2% YoY. The MPC expects above-normal southwest monsoon and healthy kharif sowing to support rural demand. However, headwinds from geopolitical tensions, volatility in international commodity prices and geoeconomic fragmentation pose risks to the outlook.

In July 2024, India's Consumer Price Index (CPI) inflation dropped to 3.54% YoY, down from 5.08% YoY in the previous month. A favourable base effect largely drove the decline in inflation, as food prices experienced a sharp increase in July last year. Core inflation, which excludes food and fuel, increased to 3.37% YoY from 3.15% YoY in June 2024 due to a revision in mobile tariffs.

High-frequency indicators continue to reflect steady economic activity. India's manufacturing PMI remained strong at 57.5 in August, though it was slightly lower than the 58.1 recorded in the previous month. Credit growth remains healthy at 13.6% YoY, with retail credit growing at 17.8% YoY. GST collections were up 10% YoY in July 2024, reaching Rs 1.75 trillion.

The spatial distribution of the monsoon improved in August, with deficient rainfall in the northwest turning normal. However, the east and northeast regions continued to experience deficient rainfall. Kharif sowing also gained pace in August, reaching 97% of the normal levels as of August 23. As of August 29, 2024, reservoir storage levels are higher than both last year's levels and the normal levels for this date across all regions, except Northern India. Broadly, the monsoon, sowing, and reservoir storage positions bode well for the recovery of the rural sector.

Outlook

Central banks in developed markets, except the Bank of Japan, are currently easing monetary policy as inflation gradually returns to target levels and economic activity slows down. The US Federal Reserve is also anticipated to cut rates by 75-100 basis points in 2024. This is expected to support global equity markets.

In contrast, the Reserve Bank of India (RBI) has kept rates unchanged since February 2023, as robust economic growth provides the flexibility to focus on controlling inflation. However, a normal monsoon and good kharif production could lead to an easing of food inflation and open up the possibility of policy easing by the RBI next year.

Equity valuations remain elevated, particularly within the small and mid-cap segments. These valuations have been upheld by strong earnings growth and robust economic momentum. Despite premium valuations, the equity market outlook remains positive from the long-term perspective. The continuation of a stable policy regime provides confidence in the ramping up of the investment cycle. Additionally, a well-distributed monsoon could improve Kharif crop production, reduce food inflation, and enable the recovery of rural consumption.

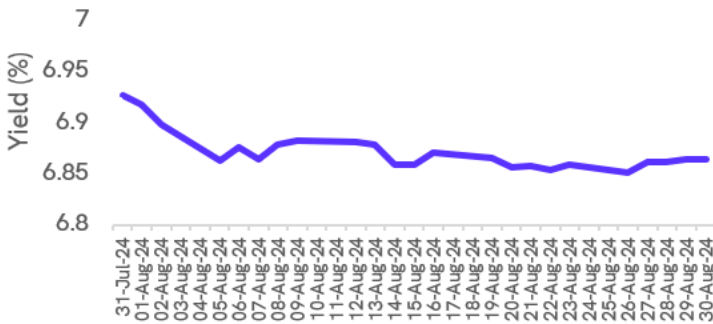
India has achieved significant progress in various macroeconomic areas, including a stable current account balance, increased government capital expenditures, fiscal consolidation, a fortified banking sector, and reduced corporate leverage. These positive trends are expected to continue. We are also witnessing a revival in private sector capex. The listed corporate sector capex has grown at a CAGR of 19% since FY21 (based on a sample of 1280 companies). We expect the private capex momentum to persist, supported by high asset turnover and capacity utilisation.

Broadly, our outlook leans more favourably towards inward-looking sectors that rely on domestic factors instead of outward-looking sectors contingent upon global influences. We remain overweight on secular and cyclicals with a robust bottom-up approach.

August 2024: Assessment and Outlook

Macros:

In July 2024, India's Consumer Price Index (CPI) inflation dropped to 3.54% YoY, down from 5.08% YoY in the previous month. The decline in inflation was largely driven by a favourable base effect, as food prices experienced a sharp increase in July last year. Vegetables witnessed a sharp increase of 14% MoM in July 2024, although this was lower than the 38% MoM increase in July 2023. Core inflation, which excludes food and fuel, increased to 3.37% YoY from 3.15% YoY in June 2024 due to a revision in mobile tariffs.

The distribution of the monsoon improved in August 2024, with cumulative rainfall in North-West India turning normal. However, rainfall in East and North-East India continues to be deficient. Out of 36 subdivisions, only 5 subdivisions, accounting for 16% of the land area, are currently deficient. Overall, the monsoon is 7% above the long-period average as of 31st August 2024. As of August 29, 2024, reservoir storage levels are higher than both last year's levels and the normal levels for this date across all regions except Northern India. The southern region has significantly higher storage due to excess rainfall. Reservoir levels in Northern India are expected to improve as the monsoon progresses.

Kharif sowings have been progressing well. After experiencing a delay in June and July, sowings picked up in August. By August 23, 2024, kharif crops had been sown on 106.5 million hectares, marking a 1.9 percent increase compared to the same period last year. Nearly 97 percent of the normal sowing for the season has been completed. As of August 23, 2024, the acreage of rice sown was the highest compared to the corresponding periods over the past five years.

The RBI's Monetary Policy Committee (MPC) voted 4-2 to keep the repo rate steady at 6.5% and retain the stance of withdrawal of accommodation. The food inflation risks dominated the outlook. The RBI retained the FY25 real GDP growth estimate at 7.2% and the headline inflation projection at 4.5%. However, the RBI increased the 2QFY25 inflation estimate by 60 bps to 4.4%.

The central government recorded an impressive growth of 21% YoY in gross tax collections till July 2024, led by direct taxes (34% YoY) and, specifically, income tax collections (53% YoY). The growth in indirect tax collections was comparatively muted at 7% YoY. Overall, net tax revenue to the centre (after adjusting for transfer to states) increased at 23% YoY. Non-tax revenue recorded a robust growth of 69% YoY, driven by a significant Rs 2.1 trillion dividend transfer by the RBI this fiscal. The pace of expenditure, however, remained muted at -6% YoY, largely on account of a 18% YoY contraction in capital expenditure. Overall, the FYTD fiscal deficit is tracking at 17% of the FY25 budget target, much lower than the 34% of budget estimate achieved last year.

The new Unified Pension Scheme (UPS) was announced over last weekend which can have a potential negative impact on both the central and the state's fiscal deficit. The estimates of the impact on the fiscal currently differs with the government estimating the impact to be Rs.62.50bn while some other estimates are talking about an impact of around Rs.400-450bn which can result in a fiscal impact of 15bps. Credit growth in the banking system remained healthy in August 2024 at 13.6% YoY (9th August), while deposit growth was lower at 10.9% YoY. The credit-to-deposit ratio remained elevated at 79.1%.

Global:

The Fed Chair at the Jackson Hole conference said, "... the time has come for policy to adjust... the direction of travel is clear, and the timing and pace of rate cuts will depend on incoming data, the evolving outlook, and the balance of risks." Markets interpreted these statements as a signal that the rate-cut cycle might begin with the September policy. The US CPI inflation slowed for a fourth consecutive month to 2.9% in July 2024, the lowest since March 2021, compared to 3% in June. Core CPI inflation also slowed for a fourth consecutive month to 3.2%, the lowest reading since April 2021,

compared to 3.3% in June. The unemployment rate rose by 20 basis points to 4.3%, triggering the Sahm rule, which indicates a recession when the three-month moving average of the unemployment rate rises by 0.5 percentage points above the low of the previous 12 months.

The 10-year U.S. Treasury yield eased by 28bps in the 10-year benchmark paper as markets discounted 50bps rate cut till end of calendar year although it increased also to 3.86% from a monthly low of 3.74% as investors assessed the chances of the U.S. economy avoiding a recession. The yield spread between the 2-year and 10-year Treasury notes, a key indicator of growth expectations, is poised to un-invert. This reduced inversion indicates that the bond market expects the Federal Reserve to begin an easing cycle. Our assessment of past four recessions in the US reveals that typically re-inversion of yield curve is followed by a recession after 4.5 months on an average, which lasts for ~11 months. Currently the yield curve is yet to re-invert (-0.2%). Post Fed Chair Powell's speech at the Jackson Hole, markets have now factored-in policy easing, which reflected in weakening US Dollar index to lowest levels since Oct'22.

Markets:

Overall, in the month of August, Indian yields steadily came down by 6-7 bps across the curve as expectations of monetary easing in the US firmed up along with other developed markets helping bond market. The benchmark 10yr bond yield ended the month at 6.86% with steady FPI flows, softer commodity prices and supportive global bond movement. Short-term yields between one and three years remain relatively high because of demand for deposits from banks amid lower deposit growth compared to credit growth. In contrast, long term yields between 10 and 40 years have decreased due to demand for government securities.

FPI inflows into debt remained stable with USD 2.14bn coming in the month of August. Cumulatively, the CYTD 2024 FPI inflows into debt have been USD 13.08 bn so far. Markets are still running with a base case of at least three rate cuts by Fed in 2024 and 1 rate cut by RBI in Dec which is quite possible given India's inflation is expected to moderate to 4.5% with food inflation showing signs of slowing down.

Liquidity for the month improved with overnight rates easing by 10-15bps with average daily surplus increasing from 1 lakh cr to 1.47 lakh cr resulting in easing of money market rates. Going ahead, we expect liquidity to remain in surplus around the current levels aided by spill-over from month-end government spending and RBI FX intervention towards the end of the previous week. Beyond the GST and advance tax led frictional tightness in September, we continue to expect liquidity conditions to remain comfortable.

Outlook:

The US Fed is all set to start cutting policy rates from September onwards and in the backdrop of global monetary easing, Indian bonds remain attractive on back of strong and stable underlying macro-economic factors and favourable demand supply dynamics at play. Two key uncertainties are facing markets in the remainder of 2024 is firstly, will the US be able to pull off a soft landing? Second, what are the implications of the US election for markets? The scope for rate cuts in India is on account of high real positive rates and the need to encourage private investment and there is a fair probability of rate cuts beginning from CY25 onwards. We are pencilling in total 50bps rate cut in this rate easing cycle. Bond yields tend to move in advance of rate action and investors can look to increase allocation to fixed income at every uptick in yields. We expect long bond yields to continue to drift lower over the next couple of quarters. We expect the benchmark 10yr bond yield to go towards 6.50% by Q4 of FY25. In the near-term we continue to expect the 10-year G-sec yield to trade in the range of 6.80-6.95% in the near term. Investors with medium to long term investment horizon can look at Dynamic Bond Funds having duration of 6-7yrs with predominant sovereign holdings as they offer a better risk-reward.

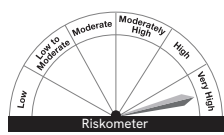

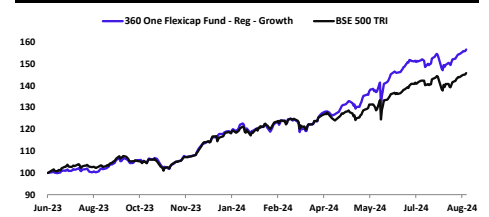


Market Capitalisation wise Exposure^

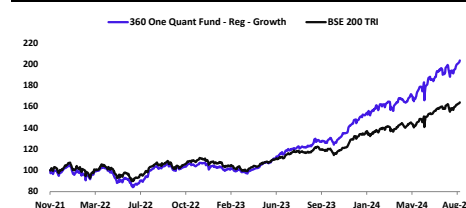

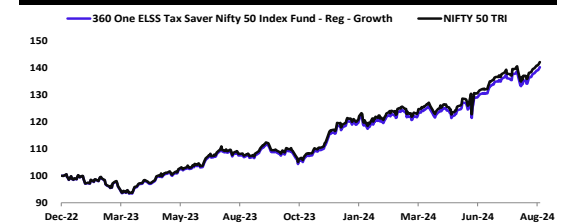

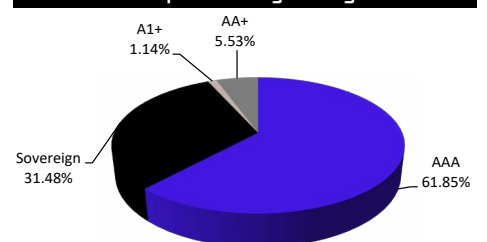


Market Capitalisation wise Exposure ^



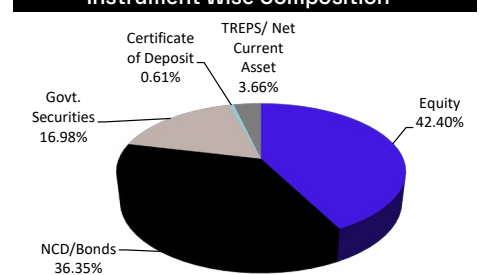

Composition by Rating ^



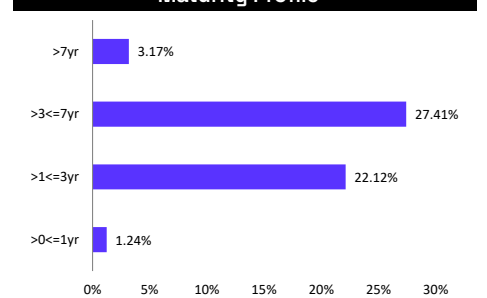

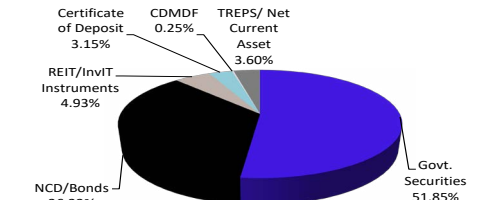

Composition by Rating^



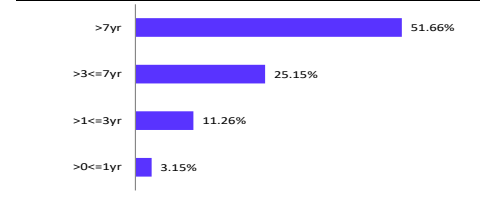

Instrument Wise Composition^



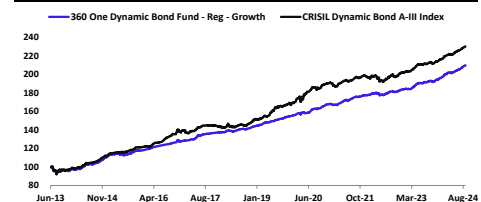

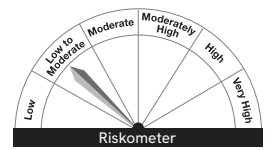

FUND MANAGER	An employee of the asset management company such as a mutual fund or life insurer, who manages investments of the scheme. He is usually part of a larger team of fund managers and research analysts.
APPLICATION AMOUNT FOR FRESH SUBSCRIPTION	This is the minimum investment amount for a new investor in a mutual fund scheme.
MINIMUM ADDITIONAL AMOUNT	This is the minimum investment amount for an existing investor in a mutual fund scheme.
YIELD TO MATURITY	The Yield to Maturity or the YTM is the rate of return anticipated on a bond if held until maturity. YTM is expressed as an annual rate. The YTM factors in the bond's current market price, par value, coupon interest rate and time to maturity.
SIP	SIP or systematic investment plan works on the principle of making periodic investments of a fixed sum. It works similar to a recurring bank deposit. For instance, an investor may opt for an SIP that invests ₹ 500 every 15th of the month in an equity fund for a period of three years.
NAV	The NAV or the net asset value is the total asset value per unit of the mutual fund after deducting all related and permissible expenses. The NAV is calculated at the end of every business day. It is the value at which the investor enters or exits the mutual fund.
BENCHMARK	A group of securities, usually a market index, whose performance is used as a standard or benchmark to measure investment performance of mutual funds, among other investments. Some typical benchmarks include the Nifty, Sensex, BSE200, BSE500, 10-Year Gsec.
ENTRY LOAD	A mutual fund may have a sales charge or load at the time of entry and/or exit to compensate the distributor/agent. Entry load is charged at the time an investor purchases the units of a mutual fund. The entry load is added to the prevailing NAV at the time of investment. For instance, if the NAV is ₹ 100 and the entry load is 1 %, the investor will enter the fund at ₹ 101.
EXIT LOAD	Exit load is charged at the time an investor redeems the units of a mutual fund. The exit load is deducted from the prevailing NAV at the time of redemption. For instance, if the NAV is ₹ 100 and the exit load is 1%, the redemption price would be ₹99 per unit.
MODIFIED DURATION	Modified duration is the price sensitivity and the percentage change in price for a unit change in yield.
STANDARD DEVIATION	Standard deviation is a statistical measure of the range of an investment's performance. When a mutual fund has a high standard deviation, it means its range of performance is wide, implying greater volatility.
SHARPE RATIO	The Sharpe Ratio, named after its founder, the Nobel Laureate William Sharpe, is a measure of risk-adjusted returns. It is calculated using standard deviation and excess return to determine reward per unit of risk.
BETA	Beta is a measure of an investment's volatility vis-a-vis the market. Beta of less than 1 means that the security will be less volatile than the market. A beta of greater than 1 implies that the security's price will be more volatile than the market.
R-SQUARED	R-squared measures the relationship between a portfolio and its benchmark index. It measures the correlation of the portfolio's returns to the benchmark's returns.
TREYNOR RATIO	Developed by Jack Treynor, the Treynor ratio (also known as the "reward-to-volatility ratio") attempts to measure how well an investment has compensated its investors given its level of risk. The Treynor ratio relies on beta, which measures an investment's sensitivity to market movements, to gauge risk.
AUM	AUM or assets under management refers to the recent updated cumulative market value of investments managed by a mutual fund or any investment firm.
TRACKING ERROR	Means the annualized standard deviation of the difference in daily returns between the underlying index and the NAV of the Scheme.
TRACKING DIFFERENCE	Means the annualized difference of daily returns between the index and the NAV of the Scheme.
HOLDINGS	The holdings or the portfolio is a mutual fund's latest or updated reported statement of investments/securities. These are usually displayed in terms of percentage to net assets or the rupee value or both. The objective is to give investors an idea of where their money is being invested by the fund manager.
NATURE OF SCHEME	The investment objective and underlying investments determine the nature of the mutual fund scheme. For instance, a mutual fund that aims at generating capital appreciation by investing in stock markets is an equity fund or growth fund. Likewise, a mutual fund that aims at capital preservation by investing in debt markets is a debt fund or income fund. Each of these categories may have sub-categories.
RATING PROFILE	Mutual funds invest in securities after evaluating their creditworthiness as disclosed by the ratings. A depiction of the mutual fund in various investments based on their ratings becomes the rating profile of the fund. Typically, this is a feature of debt funds.
IDCW	Dividend option is renamed as Income Distribution cum Capital Withdrawal (IDCW) option for all Schemes effective from April 1, 2021

Note: SEBI, vide circular dated June 30, 2009 has abolished entry load and mandated that the upfront commission to distributors will be paid by the investor directly to the distributor, based on his assessment of various factors including the service rendered by the distributor.
