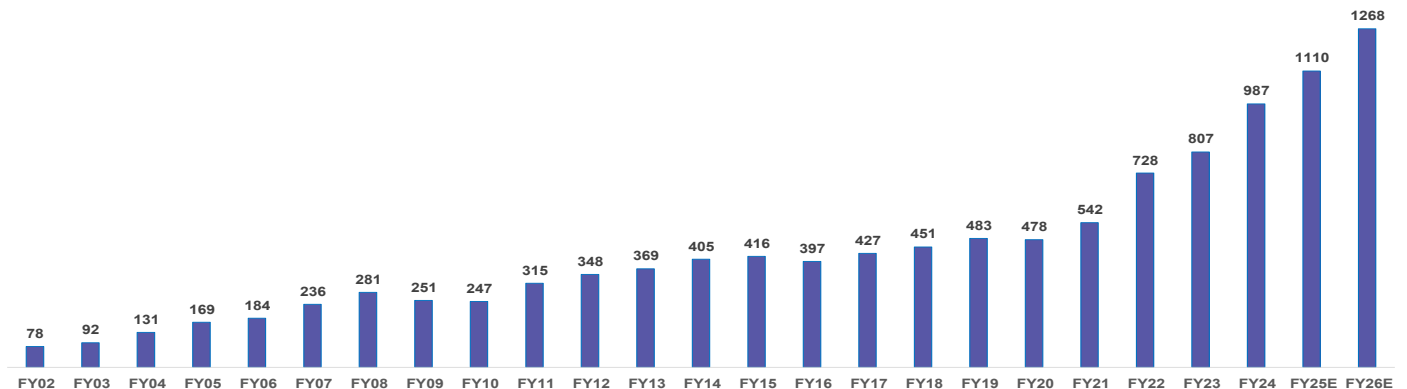

Equity Market

Indian Equity Markets: January 2026

India's benchmark equity indices corrected during the month on account of persistent selling by Foreign Portfolio Investors (FPIs), geopolitical uncertainty, and caution ahead of the Union Budget. The Nifty 50 and BSE Sensex indices posted monthly losses of 3.1% and 3.5%, respectively, in January 2026. FPIs were net sellers of US\$4.0 bn in January, while Domestic Institutional Investors (DII) bought US\$7.6 billion during the month.

Broader market indices underperformed, with BSE Midcap and BSE Small Cap posting monthly losses of 3.8% and 6.3%, respectively. Among sectoral indices, Defence, Metals and PSU outperformed with monthly gains of 5.6%, 5.5%, and 4.5%, respectively. In contrast, Real Estate, FMCG, and Consumer Durables significantly underperformed, recording monthly losses of 10.3%, 7.9%, and 7.8%, respectively.

The Union Budget 2026 focused on targeted reforms to boost manufacturing and build resilient supply chains. It laid out a roadmap to scale up manufacturing across seven strategic sectors, backed SMEs with dedicated funds and faster financing, and enhanced infrastructure in Tier II and III cities, expanded cargo corridors, waterways, and seaplane connectivity. The budget also aimed to deepen corporate bond markets, attract global businesses via targeted tax incentives, and reduce key input customs duties while streamlining procedures.

The budget projected a realistic nominal GDP growth of 10% YoY for FY27. The budget projected healthy 11.5% YoY growth in capital expenditure for FY27, though the revised estimate for FY26 was muted at 4.2%. Capital outlay on defence grew by 16.7% YoY and 17.6% YoY in FY26RE and FY27BE, respectively. Roads and railways capex showed limited growth in FY26RE, but the budget set a moderate growth target for FY27BE. Overall, the quality of spending improved, as the ratio of capital to total expenditure rose marginally to 23% in FY27BE from 22% in FY26RE.

The first advance estimates peg India's real GDP growth at 7.4% YoY in FY26, up from 6.5% YoY in FY25. This improvement is led by the manufacturing sector, which recorded growth of 7% YoY, compared with 4.5% YoY in FY25. The services sector also reported robust growth of 8.8% YoY in FY26, driven primarily by a 9.9% expansion in financial services+. Other sectors, including construction, trade+, and public administration+, also registered healthy growth. In contrast, the agriculture sector reported lower growth, reflecting erratic monsoon rainfall.

On the demand side, private consumption showed some moderation, easing to 7% YoY from 7.2% in the previous year. Fixed investment remained resilient at 7.8% YoY, supported by the central government's front-loading of capital expenditure. Nominal GDP growth moderated to 8% YoY in FY26 from 9.8% YoY in FY25, as the GDP deflator (inflation) declined sharply to 0.5% YoY from 3.1% over the same period.

On 2 February 2026, India and the US announced a trade deal cutting tariffs on Indian exports from 25% to 18% and removing penalties linked to Russian oil imports. India is expected to lower trade barriers for US goods, stop buying Russian crude, boost energy and overall imports from the US, and possibly source oil from Venezuela. The United States is India's largest trading partner, with goods exports totalling US\$87 billion in FY25, accounting for 20% of India's total exports. Imports from the US stood at US\$46 billion (~6% of total India imports), resulting in a trade surplus of US\$41 billion in India's favour. India also signed a free trade agreement with the European Union.

Outlook

The budget was focused on reviving manufacturing. Multiple announcements across strategic and frontier sectors were aimed at boosting domestic manufacturing. Customs duty reductions and exemptions for key inputs are also aimed at supporting domestic manufacturing. Other initiatives to increase the IT services safe harbour threshold, and to offer tax holidays for cloud service providers and a 15% safe harbour for related entities, were targeted at new-age services. Overall, the budget focused on targeted reforms rather than big-ticket announcements to build economic resilience.

The India-US trade setting the tariff rate at 18% places India marginally ahead of other competing markets under the China+1 strategy from an export competitiveness perspective. When combined with trade arrangements with the European Union, the United Kingdom, Australia, New Zealand, the European Free Trade Association, and others, India has positioned itself as one of the most attractive manufacturing destinations for countries and corporations seeking to diversify supply chains away from China.

Market returns in 2026 are likely to be driven by steady earnings visibility rather than valuation re-ratings, with resilient domestic flows providing stability. Foreign portfolio inflows are also poised to revive as Indian rupee may stabilise after the trade deal with US given India's strong macroeconomic fundamentals, including a stable current account deficit, subdued inflation, and fiscal consolidation.

The economy's growth engine is transitioning from government-led capital spending toward private consumption, particularly discretionary segments. Multiple structural factors support a consumption rebound. Personal income tax cuts will increase household disposable income, thereby benefiting categories of discretionary spending. Inflation pressures have moderated significantly, further supporting consumption. Monetary accommodation and the RBI's relaxation of various banking norms are also leading to credit expansion.

However, the global environment is expected to remain volatile with continued trade and tariff disputes, geopolitical conflicts and heightened economic uncertainty.

Given this backdrop, we prefer domestically focused sectors over those dependent on global dynamics, as internal fundamentals provide greater resilience amid international uncertainties. This strategic bias has shaped our positioning and continues to guide our investment approach.

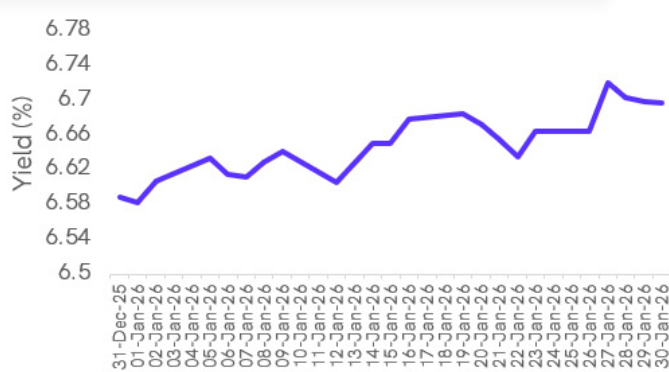

January 2026: Assessment and Outlook

Macros:

India's retail inflation rose to 1.33% YoY in December 2025 from 0.71% YoY in the previous month. The uptick was primarily driven by a lower disinflationary impact from food prices. Food inflation increased to -1.8% YoY in December 2025 from -2.8% YoY in November. Within the food basket, vegetable inflation increased to -18.5% YoY from -22.2% YoY a month earlier. The smaller seasonal decline in vegetable prices of 2.9% MoM in December, compared with a 7.4% MoM fall last year, was a key driver of the rise in headline CPI inflation. Core inflation (which excludes food and fuel) picked up to 4.7% YoY in December 2025. Excluding gold and silver, core inflation was 2.3% YoY, indicating that underlying inflationary pressures remain low.

India Union Budget 2026 stuck to the fiscal consolidation path, budgeting a 10-bps reduction in the fiscal deficit to 4.3% of GDP in FY27BE from 4.4% in FY26RE. The government targeted a debt-to-GDP ratio of 55.6 in FY27BE, down from 56.1 in FY26RE. The government aims to reduce the central debt-to-GDP ratio to 50% \pm 1% by FY31. The budget projected a realistic nominal GDP growth of 10% YoY for FY27. The projections for tax revenue (net to centre) and non-tax revenue are also credible. However, the FY27 disinvestment target has been set at an ambitious Rs 800 bn in the budget. Dividends from 'RBI and other financial institutions' are expected to remain robust at Rs 3.9 tn in FY27BE, largely driven by dividends from the RBI.

The FY27 borrowing figures are significantly higher than market expectations. Gross Borrowing was budgeted at Rs 17.2 tn, with net borrowing at Rs 11.7 tn. Short-term borrowings were also elevated at Rs 1.3 tn. Borrowings (including short-term) account for 77% of total deficit financing in FY27, higher than the 67% share in the revised estimates for FY26. As per the accepted recommendations of the 16th Finance Commission, the states' share has been retained at 41% of the net proceeds of shareable central taxes.

Credit growth increased to 13.0% YoY in mid-January 2026 from 11.8% in mid-December. Deposit growth also improved to 10.6% from 9.4% during the same period. The RBI also announced further liquidity infusion with a 90-day Variable Rate Repo (VRR) operation for an amount of Rs 250 bn, USD/INR Buy/Sell Swap auction of USD 10 billion for a tenor of 3 years and OMO purchase auctions of Government of India securities for an aggregate amount of Rs 1000 bn.

Global:

On 2 February 2026, India and the United States announced a bilateral trade agreement that lowered reciprocal tariffs on Indian exports from 25% to 18% and eliminated the 25% penal tariff imposed over Russian oil imports. While the finer details of the agreement are awaited, US President Trump's social media post suggests that India has agreed to reduce tariffs and non-tariff barriers on US imports, discontinue imports of Russian crude, and increase energy purchases from the United States and potentially Venezuela. In addition, India has committed to expanding its overall imports from the US. The India-European Union Free Trade Agreement (FTA) was also concluded on January 27, 2026.

The US Federal Open Market Committee (FOMC) kept the federal funds rate steady at 3.50-3.75% at its January 2026 meeting. The Committee continued to cite elevated economic uncertainty and balanced dual-mandate risks but removed language noting rising downside risks to employment. The FOMC upgraded its assessment of the economy, noting that economic activity is now expanding at a solid pace rather than a moderate one. The FOMC softened its language from 'rising unemployment' to 'signs of stabilisation'. At the post-policy press conference, Powell expressed confidence that the

inflation target would be achieved once the impact of tariffs wanes. The Fed considers the current monetary policy stance appropriate, as risks to employment and inflation have eased. Powell described the current fed funds rate as 'loosely neutral' and emphasised that policy will remain data driven. While Major central banks held their policy ground in January, consolidating the easing moves of late 2025.

Markets:

Indian bond yields inched up in January, as the market balanced bullish local factors against global and fiscal concerns. The benchmark 10-year G-sec yield ended the month around 6.70%, up from ~6.58% at December's close. For most of January, yields traded in a relatively tight range near multi-month lows. The bond market grew cautious about the government's forthcoming borrowing program. Traders braced for the Union Budget to announce record debt issuance for FY2026-27. This supply concern led to a mild sell-off, with the 10-year yield drifting to the upper end of recent trading ranges. Even so, the rise in yields was quite contained – the RBI's ongoing liquidity support (through open market bond purchases) and India's still-favourable inflation outlook kept bond investors confident. Globally, bond yields also ticked up modestly: the U.S. 10-year Treasury yield rose to ~4.24% in late January (from ~4.17%).

The benchmark yield curve saw a "bear steepening" effect toward the end of the month mainly due to 1.) market priced in the Union Budget's borrowing figures, 2.) over past two months banks have reduced their G-sec purchases creating room to extend credit by selling some of their holdings, 3.) dampening sentiment was the decision to defer India's inclusion in the Bloomberg Global Aggregate Index by at least six months leading to a demand-supply mismatch in the bond market plus the currency pressure. RBI's record 2025 liquidity (₹11.7 tn via OMOs/FX swaps/CRR cuts) continues, with even auctions and potential OMO resumption to cap spikes. FIIs shifted to net buying with \$0.4bn, compared to a \$1.3bn sell-off in December in bond markets.

The Indian rupee continued to weaken extending the downtrend roughly 1.5%–2% against the U.S. dollar during the month, moving from ~₹90 per USD at end-2025 to about ₹92, INR has lost about 5.8% of its value, even as the average EM currency has gained ground. This occurred despite a broadly softer U.S. dollar globally – the DXY index fell another 1.4% in January (and is down over 10% YoY) amid Fed easing and improving risk sentiment. The rupee's decline, therefore, stands out over the past year for underperformance but with the two big trades deals done rupee is expected to stabilise now.

Outlook:

As the headline CPI set to rise from recent lows, it is projected to stay comfortably within the RBI's target band for the foreseeable future. We expect the RBI to maintain repo rate at current low levels with long pause with an outside chance of 25bps rate cut in coming quarters. While higher gross issuance can put upward pressure on bond yields, the US India trade deal could improve investor sentiment toward India, especially if it is accompanied by reforms aimed at increasing economic productivity and improving the ease of doing business. This could lead to increased foreign investment in Indian bonds.

We maintain a cautiously positive outlook on the Indian bond market recommending a cautiously positive stance: overweight 3-7Y intermediates for carry with a small location towards tactical position in longer-end G-sec. The current spike in yields to 6.80% offers an attractive entry point for long-term investors as the real yields in India (Nominal Yield - Inflation) remain one of the highest globally at ~4.5%–5.0%. Indian 10Y G-Sec yields are projected to remain range-bound at 6.65–6.80% amid Q1 FY26 heavy borrowing entering into a consolidation phase with long pause on rate front but high on liquidity and bond supportive macros.

Precious metal outlook

Gold -

Gold prices soared to life highs, peaking above \$5620.8/oz in January before correcting to 4428.7/oz. The correction was driven by reduction in trading limits by Chinese regulators, increase in margin on precious metals positions followed by announcement of new FED governor that led to spike in Dollar index.

Gold may be able to “hold higher” (i.e., a new floor) but upside may be more limited unless there’s a big shock (e.g., major inflation, fiscal crisis, de-dollarisation).

Factors supporting gold Prices -

- Aggressive central bank buying—especially by China and India—despite high prices
- Continued monetary accommodation. U.S GDP growth number is good but labour market is under pressure.
- Persistent inflation, geopolitical tension, and trade policy uncertainty under President Trump.

Risks / headwinds

- If the Fed hikes rates or surprises to the upside on inflation, gold could face downward pressure.
- A strong U.S. dollar (due to economic recovery, rate differentials) would hurt gold’s appeal.
- If investor sentiment shifts from safe-haven to risk-assets, demand could drop.

Silver –

Silver broke its 14-year resistance at \$49.5 earlier in the year and surged past \$122/oz at its peak; prices remain elevated at \$70–\$85/oz. Silver’s run was fuelled by rising industrial demand—especially from the solar and electronics sectors—combined with speculative interest and tight physical markets. Industrial demand has limited sharp corrections, though volatility remains high.

Factors supporting silver prices.

- Structural supply deficits that continue to deepen.
- Strong industrial demand, particularly from solar and electronics sectors.
- Robust ETF inflows and renewed investment interest.

Risks / headwinds

- Because silver has both safe-haven and industrial-commodity features, a drop in industrial demand could hurt it more than gold.
- Contraction in Industrial and investment demand post run up.
- Risk of government intervention to curb on speculation and hoarding because its critical metal for Industry.
- If the dollar strengthens or interest rates rise, silver may be hit doubly (safe-haven appeal drops + industrial demand slows).

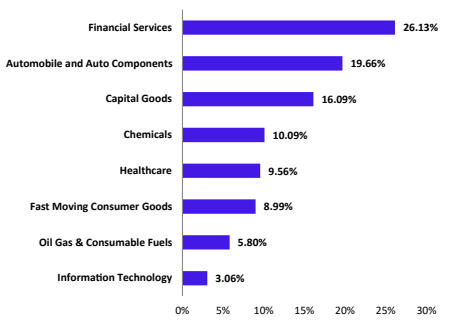

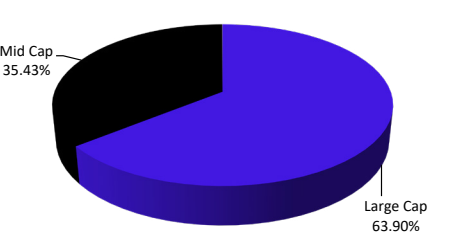

^^Sector allocation as per AMFI classification

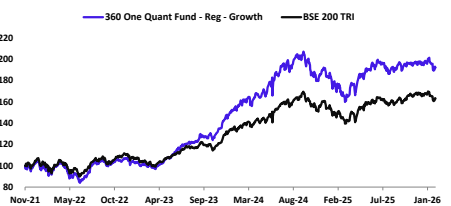
Market Capitalisation wise Exposure^

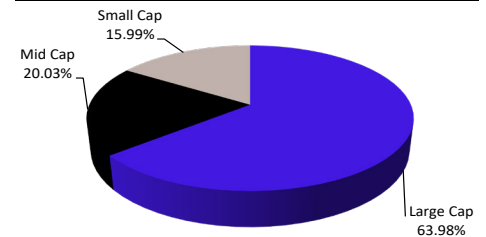

Market Capitalisation wise Exposure^

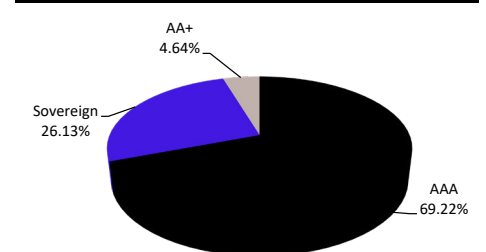

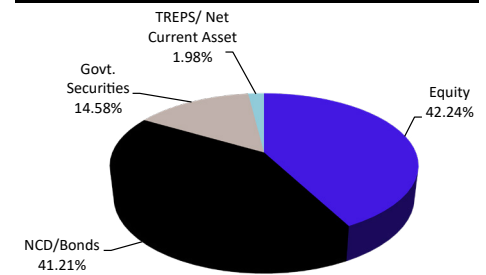
Composition by Rating^

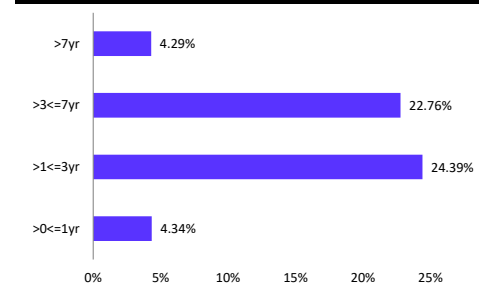

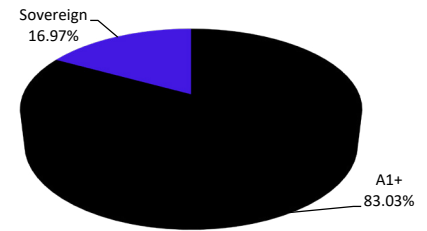

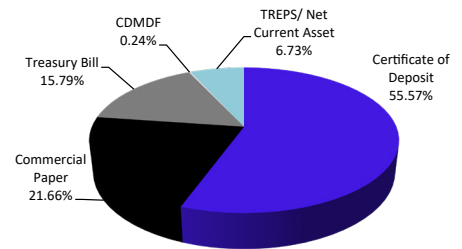

Instrument Wise Composition[^]



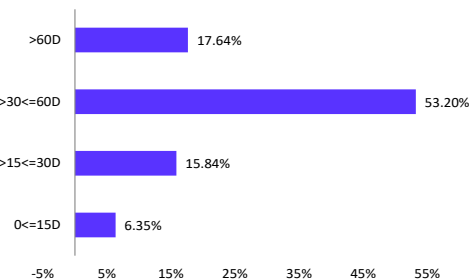

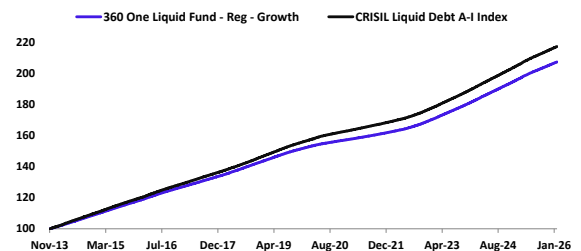

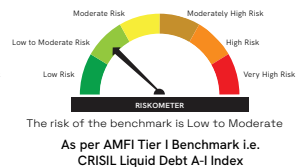
NAV Movement (Since Inception) Rebased to 100

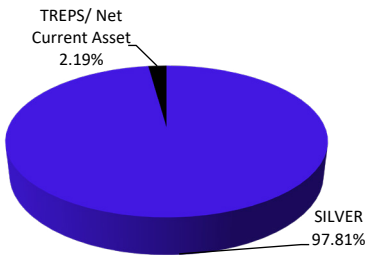

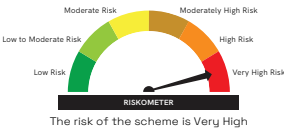

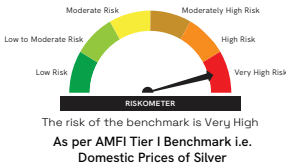

GLOSSARY OF TERMS

FUND MANAGER	An employee of the asset management company such as a mutual fund or life insurer, who manages investments of the scheme. He is usually part of a larger team of fund managers and research analysts.
APPLICATION AMOUNT FOR FRESH SUBSCRIPTION	This is the minimum investment amount for a new investor in a mutual fund scheme.
MINIMUM ADDITIONAL AMOUNT	This is the minimum investment amount for an existing investor in a mutual fund scheme.
YIELD TO MATURITY	The Yield to Maturity or the YTM is the rate of return anticipated on a bond if held until maturity. YTM is expressed as an annual rate. The YTM factors in the bond's current market price, par value, coupon interest rate and time to maturity.
SIP	SIP or systematic investment plan works on the principle of making periodic investments of a fixed sum. It works similar to a recurring bank deposit. For instance, an investor may opt for an SIP that invests ₹ 500 every 15th of the month in an equity fund for a period of three years.
NAV	The NAV or the net asset value is the total asset value per unit of the mutual fund after deducting all related and permissible expenses. The NAV is calculated at the end of every business day. It is the value at which the investor enters or exits the mutual fund.
BENCHMARK	A group of securities, usually a market index, whose performance is used as a standard or benchmark to measure investment performance of mutual funds, among other investments. Some typical benchmarks include the Nifty, Sensex, BSE200, BSE500, 10-Year Gsec.
ENTRY LOAD	A mutual fund may have a sales charge or load at the time of entry and/or exit to compensate the distributor/agent. Entry load is charged at the time an investor purchases the units of a mutual fund. The entry load is added to the prevailing NAV at the time of investment. For instance, if the NAV is ₹ 100 and the entry load is 1 %, the investor will enter the fund at ₹ 101.
EXIT LOAD	Exit load is charged at the time an investor redeems the units of a mutual fund. The exit load is deducted from the prevailing NAV at the time of redemption. For instance, if the NAV is ₹ 100 and the exit load is 1%, the redemption price would be ₹99 per unit.
MODIFIED DURATION	Modified duration is the price sensitivity and the percentage change in price for a unit change in yield.
STANDARD DEVIATION	Standard deviation is a statistical measure of the range of an investment's performance. When a mutual fund has a high standard deviation, it means its range of performance is wide, implying greater volatility.
SHARPE RATIO	The Sharpe Ratio, named after its founder, the Nobel Laureate William Sharpe, is a measure of risk-adjusted returns. It is calculated using standard deviation and excess return to determine reward per unit of risk.
BETA	Beta is a measure of an investment's volatility vis-a-vis the market. Beta of less than 1 means that the security will be less volatile than the market. A beta of greater than 1 implies that the security's price will be more volatile than the market.
R-SQUARED	R-squared measures the relationship between a portfolio and its benchmark index. It measures the correlation of the portfolio's returns to the benchmark's returns.
TREYNOR RATIO	Developed by Jack Treynor, the Treynor ratio (also known as the "reward-to-volatility ratio") attempts to measure how well an investment has compensated its investors given its level of risk. The Treynor ratio relies on beta, which measures an investment's sensitivity to market movements, to gauge risk.
AUM	AUM or assets under management refers to the recent I updated cumulative market value of investments managed by a mutual fund or any investment firm.
TRACKING ERROR	Means the annualized standard deviation of the difference in daily returns between the underlying index and the NAV of the Scheme.
TRACKING DIFFERENCE	Means the annualized difference of daily returns between the index and the NAV of the Scheme.
HOLDINGS	The holdings or the portfolio is a mutual fund's latest or updated reported statement of investments/securities. These are usually displayed in terms of percentage to net assets or the rupee value or both. The objective is to give investors an idea of where their money is being invested by the fund manager.
NATURE OF SCHEME	The investment objective and underlying investments determine the nature of the mutual fund scheme. For instance, a mutual fund that aims at generating capital appreciation by investing in stock markets is an equity fund or growth fund. Likewise, a mutual fund that aims at capital preservation by investing in debt markets is a debt fund or income fund. Each of these categories may have sub-categories.
RATING PROFILE	Mutual funds invest in securities after evaluating their creditworthiness as disclosed by the ratings. A depiction of the mutual fund in various investments based on their ratings becomes the rating profile of the fund. Typically, this is a feature of debt funds.
IDCW	Dividend option is renamed as Income Distribution cum Capital Withdrawal (IDCW) option for all Schemes effective from April 1, 2021

Note: SEBI, vide circular dated June 30, 2009 has abolished entry load and mandated that the upfront commission to distributors will be paid by the investor directly to the distributor, based on his assessment of various factors including the service rendered by the distributor.
